


TORONTO, ONTARIO, CANADA
13-15 MAY 2015

In mid-May 2015, the Ryerson Department of Criminology, in collaboration with the Ryerson Centre for Immigration and Settlement, will welcome more than 200 individuals to Toronto to participate in the eighth annual CARFMS conference. This year's

theme is *Advancing Protection and Fostering Belonging in a Global Era of the Criminalization of Migration*.

The criminalization of migration refers broadly to the increasing use of criminal law measures against migrants and refugees, as well as those who come into contact with or help forced migrants. This process engenders far-reaching impacts on all institutional levels of immigration and asylum systems as well as on the journeys and experiences of forced migrants. This trend towards criminalization is worrisome to observers of forced migration because of its reverberating detrimental effects on the current and future protection rights and privileges given to people who cross national borders. Criminalization touches upon law, public policy, social services, and other practical and theoretical aspects of

public life that prove crucial to the survival and integration of forced migrants.

In keeping with the CARFMS tradition, this year's conference focuses on local, provincial, and national scales in Canada while continuing to undertake international and transnational studies. Towards creating opportunities for advancing human rights protection in the face of the normalizing of criminalization, the conference features research and presentations on new approaches, research methods and theories. Inspiration and points of comparison will be found in the exchange of ideas on the changes, achievements, challenges, and short and long-term options abroad. Honouring our commitment to bilingual knowledge exchange and dissemination, the main

lectures will have simultaneous translation options available for all audience members.

The Toronto CARFMS conference is designed to encourage synergistic exploration of research and ideas among academics, practitioners, community and media representatives spanning diverse disciplines and professional backgrounds. In a variety of forums, we will explore questions on the practical, social, legal, policy-oriented and theoretical ramifications of the era of criminalization of migration.

In addition to more than thirty panels or roundtables comprising approximately 140 speakers, the conference will feature a public lecture by Prof. François Crépeau, the United Nations Special Rapporteur on the Human Rights of Migrants. There will

also be three keynote addresses by (i) Olivia Chow, former Member of Parliament and Toronto City Councillor; (ii) Mario Dion, the Chairperson of the Immigration and Refugee Board, and (iii) Justice Anne Mactavish of the Federal Court of Canada. Finally, this year's conference will include three plenary

sessions with esteemed opinion leaders discussing (i) how to foster migrants' sense of belonging; (ii) the global state of refugee law, and (iii) the best means and practices for advancing refugee rights.

Some of the world's leading scholars, policy makers, and practitioners in the field will be presenting at CARFMS15. The conference treats both the large and more particular issues as significant for academics, practitioners, and policymakers. Some of the lectures and discussions will unpack the "big picture"—namely, the discourses, norms, procedures, and practices of immigration and asylum systems as well as settlement and integration policies in Canada and abroad. Others will explore the nuts and bolts of criminalization, including impacts on health, education, social welfare, employment and law

enforcement and the differential experiences of migrants stemming from identity power relations based on gender, age, ability, sexual orientation and other axes of “difference”.

Beyond the social advantages of providing a place to meet and exchange ideas, the eighth annual CARFMS conference will increase the profile of studies in forced migration, refugee, immigration and settlement in all fields of the social sciences and the humanities through knowledge creation, exchange, and dissemination. As an extremely multicultural metropolis that serves as the major gateway for immigrants and refugees, Toronto is an

ideal city for the study of migration. The city is also home to several public and private organizations and agencies working for and with migrants and refugees. Ryerson University, too, is renowned as a research institution that is deeply global and multicultural with a high proportion of first- and second-generation Canadian students.

The conference will weave stronger networks amongst Greater Toronto Area early-career academic researchers, graduate students, national, provincial, and municipal policy makers, decision-makers, regional non-governmental agencies, community representatives and stakeholders as well as a sizable national and international contingent expected to attend. With the growing criminalization of migrants and refugees, strengthening these bonds can encourage much-needed innovation in the advancement of research on refugee protection and social inclusion.

Mario Dion is the Chairperson of the Immigration and Refugee Board of Canada. He has a strong legal background and significant experience in strategic and operational management. He has served in various senior roles in the public service, including as Associate Deputy Minister of Justice, Executive Director and Deputy Head of the Office of Indian Residential Schools Resolution of Canada, and as Chair of the National Parole Board. He was appointed to the position of Integrity Commissioner in December 2011, having served as Interim Commissioner since December 2010.

The Honourable Anne L. Mactavish, Justice of the Federal Court was appointed President of the Human Rights Tribunal Panel in 1995, and Chairperson of the Canadian Human Rights Tribunal in 1998. Mactavish was also President of the County of Carleton Law Association. She was appointed Judge of the Federal Court and Member ex officio of the Federal Court of Appeal on November 19, 2003. She was appointed as a Judge of the Court Martial Appeal Court of Canada on March 23, 2004.

QUESTION #1

What is the role of the CARFMS president ?

My main role is to represent CARFMS, promote its activities and enhance its membership. The CARFMS Annual Conference is extremely important in this regard. Our conference attracts some of the leading researchers, academics, policy makers, practitioners, advocates and students in the field of refugee and forced migration studies. This bilingual conference is now one of the leading annual forums for scholarly and inter-sectoral debate about the impact and consequences of policy changes on refugees, and migration more broadly. Also, it provides the opportunity for graduate and undergraduate students to present their research results, most notably through the CARFMS Student Essay Contest. It therefore contributes to the training of future professionals in this field. For these reasons, I attach great importance to the success of our next annual conference.

Pourriez-vous nous parler du rôle du président de l'ACERMF ?

Mon rôle principal est de représenter l'ACERMF, promouvoir ses activités et sa visibilité. La Conférence annuelle de l'ACERMF est extrêmement importante à cet égard. Notre conférence rassemble non

seulement des chercheurs et des universitaires de premier plan, mais aussi des décideurs, des membres d'ONG, des avocats et des étudiants dans le domaine des réfugiés et des études sur les migrations forcées en particulier et les migrations en général. Au cours des dernières années, cette conférence bilingue est devenue l'un des principaux forums annuels pour le débat académique et le dialogue intersectoriel dans le domaine. De plus, la Conférence offre aux étudiants de premier cycle universitaire et de cycles supérieurs l'opportunité de présenter leurs résultats de recherche à travers notamment le concours d'essai pour étudiants de l'ACERMF. Elle contribue donc à la formation des professionnels de demain. Pour ces raisons, en tant que présidente, j'attache une grande importance à la réussite de notre prochaine conférence annuelle.

QUESTION #2

The 2015 Conference will be held at Ryerson University from 13-15 May and it focuses on "Advancing Protection and Fostering Belonging in a Global Era of the Criminalization of Migration". What are the reasons behind choosing this theme?

The conference theme is both timely and topical. Our aim is to draw attention to the increasing use of criminal law measures,

the criminalizing discourse and other policies and practices that stigmatize and/or diminish the rights of migrants and refugees, as well as those who come into contact with or help forced migrants in Canada and internationally. The conference will explore the repercussions of these alarming developments on the immigration and asylum systems in Canada and other host states, and for the situation of not only forced migrants, but also for legal migrants. The annual conference will also discuss the achievements, challenges and short and long-term options for advancing the protection of migrants and fostering their belonging in their receiving societies.

La Conférence de cette année aura lieu du 13 au 15 mai à l'Université Ryerson. Elle portera sur le thème « Promouvoir la protection et favoriser le sentiment d'appartenance à l'ère de la criminalisation des migrations ». Pourquoi avoir choisi ce thème ?

La conférence porte sur un sujet de grande importance et d'actualité. Notre objectif est d'attirer l'attention sur le recours croissant par les États aux mesures de droit pénal en vue de contenir les migrations et punir les migrants et les réfugiés au Canada et à l'étranger. La conférence va explorer le discours criminalisant ainsi que les autres politiques et pratiques visant les migrants. Elle offrira un forum pour discuter des répercussions de ces développements sur

les systèmes d'immigration et d'asile, et sur les droits des migrants tant forcés que légaux. Nous nous attendons également à avoir des présentations et échanges relativement aux réalisations accomplies et défis rencontrés par différents acteurs, débattre des solutions à court et à long terme pour faire progresser la protection des migrants et favoriser leur établissement et intégration au Canada et dans d'autres pays.

QUESTION #3

What makes Ryerson University special for hosting the upcoming conference?

Ryerson University is a deeply global and multicultural institution. It also has a well-established reputation as the pre-eminent site of knowledge development and exchange with governments, community organizations, and academics. Our conference theme is of particular relevance to my Department of Criminology, which is playing a leading role in the conference planning and organization together with Ryerson's Centre for Immigration and Settlement (RCIS). RCIS has a long-standing reputation for organizing large, multidisciplinary events, as well as recognized expertise in the field of immigration and settlement. Its affiliated large multidisciplinary network of academics, students, and refugee and settlement agencies will ensure wider

outreach to researchers, students in different universities, community representatives and other stakeholders in the GTA. Moreover, Ryerson University is located strategically in the heart of downtown in the City of Toronto, providing all conference participants easy access to all of the major academic, cultural, historical, and shopping attractions that Canada's largest city has to offer. I believe that the venue will greatly contribute to the success of the conference.

Pourquoi avoir choisi Ryerson comme l'université hôte?

L'Université Ryerson est une institution profondément diverse et multiculturelle. Elle jouit d'une réputation bien établie en tant que promoteur de savoir et d'échanges entre les gouvernements, les organismes communautaires et les universitaires. Le thème de la conférence est d'un intérêt tout particulier pour le Département de Criminologie, qui joue un rôle de premier plan dans la planification et l'organisation de la conférence. QUESTION #4

I believe that the event will benefit from our faculty members' expertise and experience and, at the same time, enhance academic and policy networking and research collaborations between Ryerson faculty and students and other participants from Canada and internationally. The conference will also provide training, skills development and mentoring

opportunities for our graduate and undergraduate students who are actively involved in the planning and organization of the conference as assistants, rapporteurs, volunteers, and paper presenters. We fully anticipate that our conference will accelerate current research, generate new research collaborations and student learning at undergraduate and graduate levels.

QUESTION #6

Will you please name the organisers of the conference and the other institutions contributing to this event ?

STUDENT PARTICIPATION IN CARFMS CONFERENCE

CARFMS is committed to reaching out to students—and to building opportunities for the next generation of scholars, opinion leaders, and practitioners to meet each other face-to-face, not only to network but also to discuss pertinent issues of forced migration. This goal is being met through the structure and design of this year's conference: *Advancing Protection and Fostering Belonging in a Global Era of the Criminalization of Migration*.

Ryerson University, the site of this year's conference, is well known for its diverse approach to learning and community engagement. As a truly multicultural institution, it enlists students as partners in the process. Built into the conference are opportunities for students to connect with co-sponsors, including the International

Association of Refugee Law judges and the Canadian Association of Refugee Lawyers.

The Ryerson Centre for Immigration and Settlement (RCIS, www.ryerson.ca/rcis) aims to be a leader in the transdisciplinary exploration of international migration, integration, and diaspora and refugee studies. Recently, RCIS researchers Charity Hannan and Harald Bauder received funding from the Province of Ontario's Ministry of Training, Colleges and Universities to pursue the research project "Towards Creating a Sanctuary Province: A Review of the Literature on the Labour Market Policies, Programs, and Service Deliveries that Help Employers Utilize 'Illegalized' Immigrants' Human Capital". RCIS also plans to expand its research on illegalized migrants and refugees to include a debate on a living wage.

BUILDING THE CARFMS/ACERMF ORTT & PF WEBSITE THROUGH EXPERIENTIAL EDUCATION ASSIGNMENTS

The CARFMS/ACERMF Online Research and Teaching Tools and Practitioners Forum (ORTT & PF) is now being actively employed by instructors and students who are teaching in the field of refugee and forced migration studies. The principal purposes and objectives of CARFMS/ACERMF is “to promote and to support excellence in Canadian research and teaching of refugee and forced migration issues” and “to actively facilitate the dissemination of refugee and forced migration knowledge.” (Article 3.1 and 3.3 of CARFMS/ACERMF’s Bylaws).

The ORTT & PF, found at <http://rfmsot.apps01.yorku.ca>,

is helping to fulfill these main purposes and objectives of CARFMS/ACERMF. This is not only evident from the number of visits to this innovative online resource and through anecdotal evidence but also through the growing number of instructors who are beginning to use the ORTT & PF as an experiential education (EE) assignment in their courses.

The CARFMS/ACERMF ORTT & PF is an ongoing research project that involves a number of international collaborative partners, many of whom have used this online resource in their teaching at both the undergraduate and graduate levels. The reaction of students who have been

introduced to this website and who have used it in their learning have provided overwhelmingly positive feedback. Some instructors have even included the ORTT & PF in their course assignments and at the same time have used the students’ work, with their consent and permission, to contribute to the ongoing development of the ORTT & PF.

These types of course assignments are prototypical EE assignments. They provide students with an opportunity to work on a ‘live’, ongoing, international research assignment, under the direction and guidance of

their course instructor, while also contributing to the development of the ORTT & PF website. Students find these types of assignments to be more stimulating than the more typical abstract assignments. It also provides students with a sense of accomplishment and satisfaction knowing that their work is contributing to the dissemination of knowledge and understanding in the very field that they are studying.

These EE assignments call on students to select two terms, concepts or theoretical frameworks that are found on the ORTT & PF website, or to come up with their own, and to use the template that is found on the website to complete their EE assignment. The template incorporates the following six categories:

1. DEFINITIONS
2. EXAMPLES AND/OR ILLUSTRATIONS
3. OTHER USEFUL SOURCES
4. BIBLIOGRAPHY
5. CASE LAW, IF RELEVANT
6. OTHER RELATED TERMS

The EE assignment also stipulates how many definitions, examples and/or illustrations, other useful sources, and so on, to include under each of these categories. Students cannot select the same terms, concepts or theoretical frameworks. Once the EE assignments are completed and submitted to the instructor, they are carefully scrutinized and assessed by the instructor and graded. Students are then invited to revise their EE assignments, as directed by the instructor, for resubmission to the instructor who then makes the final determination as to whether the student's work has met the standards for the ORTT & PF website. Those students whose EE assignment are accepted for inclusion on the website are required to complete a consent form allowing the ORTT & PF website and researchers to post the work in the appropriate section of the website where the students' work is duly acknowledged.

These types of EE assignments not only allow the students to gain in-depth knowledge and understanding of a number of key concepts in refugee

and forced migration studies but also to make a meaningful contribution to the ongoing development of the CARFMS/ACERMF ORTT & PF online resource for all those working in this field.
