# WELCOME/BIENVENUE

Welcome to our first newsletter from the new CARFMS Executive Committee members, some who began in December 2021 and others who joined us over the past few months. We have a great team of dedicated individuals from Lethbridge, Alberta to Halifax, Nova Scotia who are working on various initiatives on refugees and forced migration. As a new Executive Committee, we've been working on a number of things, including Bylaws revision, CARFMS Meets, Student Essay Contest, CARFMS Webinars and new Awards, Student Workshops, and two upcoming conferences that will address current topics in refugee and forced migration studies.

According to UNHCR, there were 89.3 million forcibly displaced people in the world as a result of conflict, violence, persecution, and human rights abuses in 2021. Today, with the Russia-Ukraine War, there are over 100 million forcibly displaced people, an unprecedented number of

global displacements. Our world continues to change dramatically each year, and numbers keep rising as the world struggles to respond to the overwhelming needs of refugees and other forced migrants. I admit, I sometimes wonder where to find hope in the midst of violence. The response I give to my students in Conflict Resolution Studies (Peace and Conflict Studies) is that we must look at the successful and positive stories of resettlement and integration that are all around us. We have seen the extraordinary responses from Canada and the world in resettling Southeast Asian refugees after the Vietnam War, the Lao Secret War, and the Cambodian Genocide in the late 1970s and 1980s. In 1979-1980 alone, Canada resettled 60,000 Southeast Asian refugees, the largest number of non-European refugees (Molloy et al, 2016; Stobbe, 2022). More recently, Canada resettled 25,000 Syrian refugees between November 2015 and February 2016, and continue to respond to the humanitarian crisis (Government of Canada, 2020). In 2022, the invasion of Ukraine by Russia resulted in millions of displaced people. Canada and other States have responded by creating immigration measures and support

for Ukrainians and their families. While we celebrate the efforts that Canada has put into helping the Syrians and Ukrainians, it is important to remember that there are still millions of refugees from countries including Venezuela, Afghanistan, South Sudan, and Myanmar, many of whom have waited years in refugee camps. For whatever reason, the international community has been unable to find durable solutions for these groups and seem far less open to resettling them. Resettlement still represents less than one percent of the total refugees under UNHCR's mandate (UNHCR, 2021).

What are some other pathways or solutions to this unprecedented number of forcibly displaced people in our world? How do we address the underlying root causes of persecutions, conflicts, violence, and wars? CARFMS' upcoming two conferences will attempt to respond to these questions. In light of the uncertainty regarding Covid regulations at various institutions, CARFMS will host an online conference on "Crisis and Forced Migration: Manifestations of power in a changing world" from United College at the University of Waterloo in November 2022. Building on the topic from the online 2022 conference, our first in-person conference since the pandemic will be held at York University in May 2023. The topic for the in-person conference is on

"Racism, Rights, and the Responsibility to Protect: Re-imagining the Struggle for Equality and Justice for Refugees and the Forcibly Displaced." We hope that you will participate in our upcoming online and in-person conferences, and support CARFMS through your membership and by inviting others to get involved in these activities.

## "CRISIS" AND FORCED MIGRATION: MANIFESTATIONS OF POWER IN A CHANGING WORLD IN COLLABORATION WITH THE HUMAN RIGHTS PROGRAM AT UNITED COLLEGE AT THE UNIVERSITY OF WATERLOO



Whether used in reference to conflict, war and displacement, climate change, Covid-19, impending food shortages, or the state of democracy, the concept of crisis has become ubiquitous in modern discourse. Invoking 'catastrophe' or 'disaster,' the term 'crisis' inflames political passions and evokes an emotional response, frequently rooted in fear. Yet a 'crisis' is not inherently negative. Having its roots in the Greek 'krisis' and 'kríno,' meaning 'to decide' or 'to judge,' referring to the action or ability to separate or distinguish, a 'crisis' can also be considered a turning point/a point of inflection, an event or a state of affairs that provokes or requires a decisive response. It implies the impossibility of maintaining the status quo. It may precipitate feelings of powerlessness, or provoke responses grounded in the baser instincts of humanity – fear, prejudice, selfishness, but it can also act as a call to action, change, renewal, and solidarity. Conflict or crisis is sometimes necessary to bring about social change.

In the forced migration context, the term 'crisis' has been affixed both to specific displacements (i.e., the European migration 'crisis') and to root causes (i.e., authoritarian government). In either case, crises demand response. Does the international community come together in solidarity to redefine and reapportion global responsibility, or does it fragment with each state or region building ever higher walls to deter entrance? Do we hold on to a definition of "refugee" that offers protection to some but excludes many, or re-imagine the international protection regime to better ensure the equal dignity and respect that were its original promise?

The mobilization of the concept of 'crisis' influences our ability to respond and the responses available. As an extraordinary occurrence, a 'crisis' can be used to justify or authorize an emergency response in which the status quo may be suspended with dramatic consequences for people on the move. Indeed, both 'crises' themselves and the responses that they elicit represent manifestations of power or the lack thereof. In the migration context, the politics of power are evident in the responses to forced displacement: in the ability of the

Global North to implement policies and practices that trap displaced persons in the Global South and in the inability of less economically developed countries to hold wealthy countries accountable for their role in the root causes of displacement. The state leader who can close a border or criminalize assistance to irregular migrants exercises power. The politician who uses the vulnerability of others to stoke nationalist sentiments exercises power. The immigration officer responsible for defining and categorizing those seeking protection exercises power. However, so too does the migrant who, once displaced, rebuilds their life, the advocate who stands up for the rights of others, the academic whose research influences policy, and the refugee who makes their voice heard.

The 2022 CARFMS Conference will bring together researchers, policymakers, NGOs, practitioners, students, displaced persons, and advocates from diverse disciplinary and regional backgrounds to discuss how to claim, exercise, or resist power in responses to the multiple, overlapping global forced migration crises that currently face the world. The conference will feature keynote and plenary speeches from leaders in the field and refugees, and we welcome proposals for individual

papers, organized panels and roundtables structured around the following broad subthemes:

1. Power, Ideology, and Disruption: Challenging discourse and praxis
2. Representation, Discrimination, and Legitimacy: Claiming space to be a refugee
3. Crisis, Complicity and Responsibility: Critical approaches to understanding "root causes"
4. Resistance, Agency, and Solidarity: Reflecting on responses to forced displacement
5. Best Practices in Forced Migration Research

Join us for this great opportunity to network, discuss, learn, and share knowledge. We look forward to seeing you there!



## Virtual Workshops for Students & Early-Career Researchers/Educators



Two more workshops are planned for the coming months: the first will provide advice and guidance on how to design and deliver an effective conference presentation, while the second, hosted in collaboration with the editorial staff at *Refuge*, will focus on how to get your work published. ## CARFMS MEETS



During the pandemic and under the leadership of Dr. Stephanie Silverman, CARFMS initiated a virtual event to highlight the work of graduate students pursuing refugee and forced migration research across the country. The CARFMS Meets initiative provided an opportunity for graduate students to share their in-progress research and network with CARFMS members. It serves two key purposes: to support emerging refugee and forced migration scholars and practitioners, and to enhance CARFMS networking and outreach.

In Spring 2022, we extended this initiative and offered the first undergraduate edition with a group of undergraduate students in Dr. Morgan Poteet's 4<sup>th</sup>-year Refugee Studies seminar at Mount Allison University in New Brunswick in March 2022.

Three students presented their final portfolio paper topics and received feedback from two visiting CARFMS executive members.

The three students shared positive feedback about the opportunity to present their work to scholars from the wider academic community who focus on issues of forced migration, and to hear different perspectives.

Aura Groomes commented, "my experience presenting a course project at the CARFMS Meets event provided me the opportunity to practice my research presentation skills and get real experience presenting to academics in their discipline. I was grateful to receive feedback from and engage with academics in this field, and I was able to learn about upcoming research in the field of migration studies and how my topic could be valuable to the future of this area.

CARFMS Meets made me see that my work in courses can be applied and engaged with in academia as more than just student work, and there is substance in my projects that can be carried out into the real world."

We look forward to hosting CARFMS Meets events during the 2022-23 academic year. The Canadian South East Asia Refugee Historical Research Project  
Le projet de recherche sur l'histoire canadienne des réfugiés du Sud Est de l'Asie

**Stephanie P. Stobbe** is a principal researcher, along with Peter Duschinsky, Colleen Lundy, Michael Molloy, and Allan Moscovitch, in the Hearts of Freedom (HOF): Canadian Southeast Asian Historical Research Project. This national project conducted 175 video-recorded oral history interviews from Vancouver to Halifax. The vast majority of interviews are from former refugees (83.4%) and the remaining are from NGOs, private sponsors, and Canadian officials including former Prime Minister Joe Clark and former Minister of Employment and Immigration Lloyd Axworthy. The Southeast Asian Refugee Movement is a significant part of Canadian history as it changed immigration policies and structures and developed programs such as the Private Sponsorship of Refugees. It highlights refugee stories of successful integration and positive contributions, and current issues and areas for improvements. The project is in

partnership with the Vietnamese, Laotian, and Cambodian communities, Canadian Immigration, Historical Society, Carleton University, Canadian Mennonite University, and museums, including Canadian Museum of History, Canadian Museum of Immigration at Pier 21, and Pacific Canada Heritage Centre - Museum of Migration. The outcomes of the project include:

- (1) book - McGill-Queen's University Press;
- (2) film documentary;
- (3) academic curriculum;
- (4) website - <https://heartsoffreedom.org/>; and
- (5) curated museum exhibition. The HOF Refugee Stories Exhibition will be launched at the Canadian Museum of History in January 2023. Further details will be available on the HOF website and Museum website.

# CARFMS AWARDS / PRIX CARFMS

## CARFMS FORCIBLY DISPLACED STUDENTS AND EARLY-CAREER RESEARCHERS AWARD

CARFMS is pleased to announce the establishment of its newest award, the **CARFMS Forcibly Displaced Students and Early-Career Researchers Award**. This award will help to ensure that refugee and forced migration research is shaped by a more inclusive and equitable collective engagement, and with the objective of amplifying and highlighting the voices of those with lived experience of displacement. CARFMS has established this award to recognize the most outstanding scholarship produced by university students and early-career researchers with a lived experience of forced migration. This award is made possible thanks to the Local Engagement Refugee Research Network (LERRN) and with the support of the Borderless Higher Education for Refugees Project (BHER).

There are three categories to this award:

1. Undergraduate students;
2. Graduate and law students;
3. Early-career researcher (defined as having completed their highest degree no more than six years before the competition deadline).


The CARFMS Working Paper Series is an online publication that provides open access to papers and presentations produced by our members.
